He has an absolute passion and belief in people's ability to change direction, achieve success and become who they truly want to be.



COLIN JAMES

Key Note Speaker

Colin James is in the business of supporting, developing and promoting Professional Employees. He is in the business of building Professional Employee cultures. Over his 30 years as an Educator, Speaker, Facilitator and Trainer, he has worked with an extensive array of clients, in a variety of industries throughout Australasia, Asia Pacific, Europe and the USA.

Colin is one of those people that has spent his life exploring cultures, religions, philosophies and human psychology, which has seen him travel far and wide and have adventures others only read about. His work with people with spinal cord injury led to him working alongside Christopher Reeve and Facilitating the Australian Spinal Cord Injury Summit in 2002. Colin is not the 'motivational speaker' type. Platitudes, sound bites and tired 'Believe in yourself and anything is possible' hyperbolic stuff is not what he does. His keynotes, whilst deeply engaging (and using much humour), also challenge and provoke whilst imparting practical depth and workable knowledge.



BRANT NORTH

Key Note Speaker

Brant is a 42 year old young man who lives in Brisbane with his wife and 8 children ranging in ages from 2 months to 21. He is a wheelchair dependant bilateral amputee as a result of injuries sustained in a workplace accident that occurred on the 20th January 1999. Before his accident, Bugsy was an active person involved in a range of sports, but particularly loved rugby league which he played from the age of six. These days he is still very active and is involved in disabled sport competing in sitting volleyball and wheelchair basketball.

"The presentation itself is called 'Choices and Consequences'. The choice I made at the time resulted in the consequences I must now live with. If there is one thing I want you take away from the session is that the old saying 'it wouldn't happen to me attitude is gone. There are also three words that have stuck with me to this day... "Never give up."
